10. Review of the 2016-2017 Single Plan for Student Achievement

11.Review 2017-2018 School Budget

- Title 1 Funds Our school receives Title 1 monies because 49% of our students are low socioeconomic status (252 children out of 512 total enrollment). These funds are to support items in our Single Plan for Student Achievement and the CVESD District goals. Money can be used for teacher workshops and instructional assistants as well. A comprehensive list of how these funds can be spent will be given to SSC at the August 28th meeting. Title 1 monies have to be used the same year they are allocated. This year, we were allocated \$54,170.
- LCAP Funds These funds are used similarly to Title 1 funds. We have \$91,518 in LCAP funds for this school year. These funds carry over from year to year if they are not used.
- School Site Funds These funds are used for supplies (teacher, custodial, office, nurse/health) and other general items that may be used by the school. These funds do carry over if there is any money left at the end of the school year. This year we were allocated \$63,925.
- We will be reviewing the school budget more in depth at the next SSC meeting on August 28, 2017

12. DAC/DELAC – Updates from August 8, 2017 meeting

- Norma Prado and Amber MacDonald attended
- Norma Prado will be our DELAC representative.
- Amber Roehm (parent) who has served as the DAC (District Advisory Committee) representative in the past offered to serve again. She was at the August 8th meeting. As a SSC we unanimously agreed to this offer of Amber Roehm serving as the DAC representative. None were opposed.
